The Welding Supervisor is supported by Mr. Andreas Huber (IWS) born 09.08.1983. For internal welder qualification based on standard DIN EN ISO 9606-1 by Mr. Brugger within the scope of this welding certificate a procedure is established to weld, supervise and verify the test samples and to issue a welder certificate.

For stainless steel we recommend to apply the technical specification no. Z-30.3-6 of DIBt in Germany.

General Terms

- 1. This certificate is valid as long as the terms of the above technical specifications themselves or the manufacturing conditions of the essential manufacturing factory have not changed significantly.

- 5. The following changes must be reported to the inspection authority:
 - a) New production or significant changes to essential manufacturing facilities;

 - inception of new welding processes, new base materials and related WPQRs (welding procedure qualification record)
 - d) new essential manufacturing facilities

The inspection authority will cause a supplementary examination in the cases cited
